

**2017 SANTA BARBARA GREEK FESTIVAL  
VENDOR AGREEMENT**

This Agreement (“Agreement”) is entered into by and between the below named vendor (“Vendor”) and St. Barbara Greek Orthodox Church (“Church”) of Santa Barbara, California.

**RECITALS**

1. CHURCH. The Church shall hold a Greek Festival (“Festival”) at Oak Park in Santa Barbara located at 300 W. Alamar Avenue on **Saturday, July 29, and Sunday, July 30, 2017**. Hours are from 11:00 a.m. to 7:00 p.m. each day.

Note: Church Vendor Manager has the right to refuse the sale of Vendor items that are not listed above or agreed to in advance in writing.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. LEASED SPACE. Vendor shall be provided with covered space in the Festival market area. (Approximately 10 ft. by 10 ft.) The exact location and configuration of your space will be determined by the Festival Committee based on a variety of factors, including number of vendors participating and overall aesthetics. The space will be provided with standard 110-volt power outlets, upon request only. Any special requirements must be provided by the Vendor.

2. VENDOR OPERATION. Oak Park will be open to Vendors on **Friday, July 28**, after 3:00 p.m., to accommodate set up. Vendor shall have Vendor’s space set-up no later than 10:00 a.m. on **Saturday, Sept 29**. Vendor Agrees to have a representative at the space at all times during the Festival, and to have all representatives act and dress appropriately. Vendor understands and acknowledges that the Church makes no representation as to the number of people who will attend the Festival, the amount of business Vendor may expect, or any other matter whatsoever. Vendor understands and acknowledges that the Church is not responsible for vendor product shortage or damage.

3. PAYMENT. Vendor agrees to the booth rental fee of **\$750**, payable in full to St. Barbara Greek Orthodox Church upon application approval. Send agreement and full payment to 1205 San Antonio Creek Road, Santa Barbara, CA 93111.

4. VENDOR APPLICATION TO THE CITY OF SANTA BARBARA. Vendor is responsible for completing and submitting the special event application to the City of Santa Barbara with the fee. See attached or download:

5. BOARD OF EQUALIZATION FORM. Vendor is responsible for submitting the completed BOE-410 form along with their Vendor Agreement.

6. INDEMNIFICATION. Vendor agrees to indemnify and hold Church harmless from all claims, losses, expenses, fees including attorney fees, costs, and judgments that may be asserted against Church that result from the acts or omissions of Vendor and/or Vendor 's employees, agents, or representatives, other vendors, contractors, public entities, or members of the general public.
